## 1. Nomination

- Must be In writing accompanied by an Application form
- Must be from a current financial member and endorsed by a second financial member
- Nomination Cannot be made by an immediate family member


## 2. Life Membership Review Committee.

- Must include Club President + 2 current committee + plus 2 Life members
- Review Committee MUST include a "Holder of Historical Knowledge"
- A Verifying officer is to verify the factual elements of the nomination

3. Decision made by Review Committee

- Review Committee must conduct minuted minutes
- Verification officer must report on findings
- Decision is made by $80 \%$ Majority vote ( 4 of the 5 members) $f$ Should the nomination be declined, the nominator is to be informed in writing prior to the next presentation


## 4. An Extroadinary General Meeting is called (EGM)

- Motion is brought to the EGM by Chair of the Review Committee, and a seconder with no less than 4 weeks notice of motion
- Life membership is endorsed at EGM by majority vote:
